2013 is a crucial year for fire and building officials as you work to protect their citizens from fire. The NFPA has had residential fire sprinklers in 3 standards (101, 5000, 1) for 3 code cycles now, the ICC has residential sprinklers in the IRC codes now for 2 code cycles. California and Maryland have passed statewide residential legislation, and Illinois has 88 political entities with residential protection. Now the Illinois State Fire Marshal is advocating for an upgrade of his Statewide Code. So what are residential fire sprinklers? How are they installed? What is the technology? Why are they needed? Why do fire service organizations advocate for them? This is what this Summit is about.
